Federal and State Technology (FAST) Partnership Program To Provide Organizations with Funding for Outreach, Mentoring and Technical Assistance to R&D-focused Small Businesses Interested in the SBIR/STTR Federal R&D Programs

The U.S. Small Business Administration (SBA) plans to issue Funding Opportunity Announcement No. FAST-2018-R-0012A with estimated total program funding of \$1 million. The award ceiling is \$125,000 and the award floor is \$0. Funding will go to organizations to conduct outreach, mentoring, financial support, and technical assistance to R&D focused small businesses interested in the SBIR/STTR Programs. Applications will be considered from all states and territories that count with an SBA approved SBTDC (a Small Business Development Center with Technology accreditation). All other applicants can respond to Funding Opportunity Announcement No. FAST-2018-R-0012. This program is authorized by Public Law (P.L.) 111-117 and 15 U.S.C. 657d(c). Only one proposal from each state may be submitted to the SBA for consideration and this application must have an original, signed letter of endorsement from the state governor or equivalent.

Please note that all technical proposals must be 10 pages or less, single spaced or greater, with size 12 font. See pages 7-12 of the Funding Opportunity Announcement for Technical Proposal content and attachments. Eligible applicants are limited to Small Business Technology Development Centers.

Funds will be provided to conduct programs for a 12-month performance period. The announcement will be available at [www.grants.gov/](http://www.grants.gov/) and [www.sbir.gov/about-fast](http://www.sbir.gov/about-fast). Applications/proposals must be submitted on [www.grants.gov/](http://www.grants.gov/) and must be validated and accepted by 4:00 p.m., Eastern Daylight Time (EDT) June 20, 2018 by the SBA Office of Grants Management.
